

LIMITED WARRANTY

FIVE YEAR SURFACE WARRANTY

The spa surface is warranted to be free from defects in material and workmanship under normal use and maintenance for a period of 5 (five) years from date of original purchase. In the event of a defect of the surface, warranty is limited to repair only, of that surface, and is not guaranteed against discoloration or fading. The surface is only a finish and not part of the structure. The spa surface is warranted to the original purchaser only. The spa surface is defined as the exposed finish.

TEN YEAR SHELL WARRANTY

The spa shell is warranted to be free from defects in material and workmanship under normal use and maintenance for a period of 10 (ten) years from date of original purchase. Aahs Spas will repair or replace the spa shell at its sole discretion. As long as the spa shell holds water, the terms of the warranty are satisfied and are considered filled. Any replacement shell, new or manufactured, shall assume as its warranty period only the remaining time under this original warranty. The shell is further limited to be structurally sound, meaning capable of holding water only. The shell is further limited to 100% coverage for the first year, with a 10% reduction of coverage of the replacement price by Aahs Spas each year following the first year, until the 10 years of warranty are completed. The spa shell is warranted to the original purchaser only. The spa shell is defined as the shell below the finish. Any cost incurred for diagnosis of defects and/or failure, or for labor in the removal and/or reinstallation of the spa shell is not provided for under the terms of this warranty and shall be the sole responsibility of the purchaser.

TWO YEAR WARRANTY

Factory installed attachments and modifications are warranted to be free from defects in material and workmanship under normal use and maintenance for a period of 2 (two) years from date of original purchase. Examples of the more common factory installed modifications and attachments include (without limitation): air jets, air control switches, electrical relays, heating elements, thermostats and pumps, Any cost incurred for diagnosis of defects and/or failure, or for labor in the removal and/or reinstallation of any attachments or modifications thereto is not provided for under the terms of this warranty and shall be the sole responsibility of the purchaser. Aahs Spas warrants factory-installed plumbing against water loss due to defects in materials and workmanship for a period of 2 (two) years from date of original purchase. This does not include leaks caused by rodents or other outside effects on the spa equipment.

SERVICE, LABOR & SHIPPING COSTS

Transportation for any replacement spa or other parts covered under terms of this warranty will not be assumed by Aahs Spas. Any spa shell or other part judged to be defective during the applicable warranty, under inspection by Aahs Spas, will be repaired or replaced, FOB Aahs Spas free of charge providing the merchandise is returned freight paid to Aahs Spas, 410 N. Main St, Hillsboro, KS 67063. All such items must be accompanied by customer's written description of the claimed defect or failure, Serial Number of the item (if any), the date of the original delivery and dealer from whom purchased. If customer should have any questions as to the procedure to be followed for warranty claims or the availability of other warranty service features, please contact Aahs Spas, 410 N. Main St, Hillsboro, KS 67063.

EXCEPTIONS TO WARRANTIES

Improper installation, operation or maintenance resulting in defects or failure in the spa shell or any attachments or modifications to the spa thereto will invalidate this warranty. Abuse, negligence or accidents resulting in defects or failure in the spa shell or any attachments or modifications to the spa thereto will also invalidate this warranty. Any spa installed in violation of any building code or other codes and laws governing the area in which installed of failing to conform with acceptable trade practices, or moved from the original installation site are excluded from the coverage under the provisions of this warranty.

LIMITATIONS OF WARRANTY

All implied warranties including the implied warranty of mechanicability and where present the implied warranty of fitness are co-extensive in duration and are limited to the duration of the express warranties set forth herein. The express warranties herein are exclusive and may not be altered, enlarged or changed by any distributor, dealer or other person whatsoever. This warranty explicitly excludes liability for any and all incidental or consequential damages, which may result from any use, defect, failure or malfunction of the warranted product. The warranty is herein contingent upon full payment at the original purchase price and wholesale price to Aahs Spas, and full payment of the owner's portion of the warranty cost to Aahs Spas. Some states do not allow the exclusion of incidental or consequential damages, so the above limitation may not apply to you.

WARRANTY PERFORMANCE
